NATIONAL AFFILIATIONS

RESIDENTIAL

- **National Apartment Association (NAA):** mandatory for owners and managers of apartment buildings.
- **NAA Dues: \$30 membership fee plus \$.47 per apartment unit**

NOTE: The 8.14% of the NAA dues payment allocable to federal lobbying is no longer deductible pursuant to IRS regulations concerning lobbying.

COMMERCIAL

- **Building Owners and Managers Association (BOMA) International:** Includes 3 individual representatives; Mandatory for owners and managers of office space.
- **BOMA Dues: \$965**

NOTE: The 22% of the BOMA dues payment allocable to federal lobbying is no longer deductible pursuant to IRS regulations concerning lobbying.
